The candidates whose names appeared in the First, Second & Third Allotment Lists published by the Consortium of National Law Universities and allotted to the National University of Advanced Legal Studies, Kochi, through CLAT 2024 for admission to the 5 Year B.A. LL.B. (Hons.) Degree Course and One Year LL.M. Degree Course are required to complete the following formalities:

A candidate who selected the **Freeze Option** in the First or Second or Third round of counselling must pay the remaining University Fee (after adjusting the Counselling Registration Fee and Confirmation Fee) to NUALS concerned by **11:59 P.M. on May 14, 2024**).

**Fee Payment at NUALS**

All candidates who have selected the Freeze option in the first or second or Third round of counselling must pay the balance University Fees (after adjusting for the Counselling Registration Fee and Confirmation Fees already paid) at NUALS by 11:59 P.M. on **May 14, 2024**. Any such candidate who fails to pay their balance University Fees by this date will be deemed to have chosen the Exit option and will forfeit their seat.

**Schedule of Fees to be paid at NUALS**

**B.A. LL.B. (Hons.) Degree Course**

The total fee for the first year B.A. LL.B. (Hons.) Degree Course is Rs.2,13,,870/- (Rupees Two lakhs Thirteen thousand Eight hundred and Seventy only) and a refundable Caution Deposit of Rs.10,000/- (Rupees Ten thousand only). The Counselling Fee and Confirmation Fee remitted at the CLAT Office shall also be adjusted in the fees.



Hence, the total amount to be paid for confirmation of admission to the B.A. LL.B. (Hons.) Degree Course is

(a) Rs. 1,73,870/- (Rupees One Lakh Seventy Three thousand Eight hundred and Seventy only) including the Caution Deposit is [(Rs.2,13,870 + Rs.10,000) – (Rs.30,000 + Rs.20,000)] for General Category candidates.

(b) Rs. 1,83,870/- (Rupees One Lakh Eighty Three thousand Eight hundred and Seventy only) including the Caution Deposit is [(Rs.2,13,870 + Rs.10,000) – (Rs.20,000 + Rs.20,000)] for OBC/EWS/PWD (based on All India Category) candidates.

The candidates coming from institutions outside the State of Kerala are required to remit an additional amount of Rs.200/- (Rupees Two hundred only) towards Recognition Fee, i.e., such General Category candidates have to remit a total amount of Rs.1,74,070/- (Rupees One Lakh seventy Four Thousand and Seventy only) and such OBC/EWS/PWD (based on All India Category) candidates have to remit a total amount of Rs.1,84,070/- (Rupees One Lakh Eighty Four Thousand and Seventy only).

#### One Year LL.M. Degree Course

The total fee for the One year LL.M. Degree Course is Rs.1,52,870/- (Rupees One lakh Fifty Two thousand Eight hundred and Seventy only) and a refundable Caution Deposit of Rs.10,000/- (Rupees Ten thousand only). The Counselling Fee and Confirmation Fee remitted at the CLAT Office shall be adjusted in the fee.

Hence, the total amount to be paid for confirmation of admission to the One Year LL.M. Degree Course is,

(a) Rs. 1,12,870/- (Rupees One Lakh Twelve Thousand Eight hundred and Seventy only) including the Caution Deposit [(Rs.1,52,870 + Rs.10,000) – (Rs.30,000 + Rs.20,000)] for General Category candidates.

(b) Rs. 1,22,870/- (Rupees One Lakh Twenty Two Thousand Eight hundred and Seventy only) including the Caution Deposit [(Rs.1,52,870+ Rs.10,000) – (Rs.20,000 + Rs.20,000)] for OBC/EWS/PWD (based on All India Category) candidates.
