Applications in the prescribed form are invited for admission to the Post Graduate Diploma in Medical Law and Ethics (PGDMLE), Post Graduate Diploma in Cyber Law (PGDCL), Post Graduate Diploma in Banking Law (PGDBL), Post Graduate Diploma in Insurance Law (PGDIL) and Post Graduate Diploma in Education Law and Management (PGDELM). The number of seats for the programme shall be 50 for each programme.

The minimum qualification for admission to PGDMLE shall be a Bachelor's Degree in any subject of a recognised University. However, preference shall be given to those who possess a Bachelor's Degree in any system of Medicine, Dentistry, Nursing, Pharmacy, Hospital Administration, or a Bachelor's Degree in Law recognized by NUALS.

The minimum qualification for admission to PGDCL shall be a Bachelor's Degree in any stream or a Bachelor's Degree in Law recognized by NUALS. Preference shall be given to those who possess a Degree in Law.

The minimum qualification for admission to PGDBL /PGDIL/PGDELM shall be Bachelor's Degree in any subject of a recognised University.
