Degree and a minimum of succeeding three years for completion of Ph.D. Only on successful completion of LL.M. Degree , the candidate will be considered for admission to the regular Ph.D. Degree Programme of the University without appearing for the DAT or the UGC/NET exams as contemplated under the extant regulations.

Prospectus for the Integrated LL.M. Ph.D. Programme 2022

The Integrated LL.M. Ph.D. is a novel programme introduced in the State of Kerala for the first time by the National University of Advanced Legal Studies (NUALS), Kochi. The Programme is for a duration of five academic years with initial two years consisting of four semesters for completing LL.M. Degree and a minimum of succeeding three years for completion of Ph.D. Only on successful completion of LL.M. Degree, the candidate will be considered for admission to the regular Ph.D. Degree Programme of the University without appearing for the DAT or the UGC/NET exams as contemplated under the extant regulations.

An annual fee of Rs.25,000/- (Rupees Twenty five thousand only) shall be paid for the remaining 3 years of the Ph.D. component of the programme. The fee structure for various purposes for the NUALS Ph.D. Scholars will be applicable during the period of research.

Mode of Admission

The candidates who have passed the Bachelor's Degree examination in Law of the National University of Advanced Legal Studies or any examination recognized as equivalent thereto by the University has to undergo an entrance examination and an interview for getting admission to the Integrated LL.M., Ph.D. programme. Only five seats are open for the Integrated LL.M., Ph.D. Programme.

Date of Entrance Examination

The Entrance Test will be held at the National University of Advance Legal Studies (NUALS), Kalamassery, from 10.00 a.m. to 1.00 p.m. on Saturday, the 7th May, 2022.

Eligibility to the Ph.D. Course Component of the Integrated LL.M., Ph.D. Programme

The Centre for Post Graduate Legal Studies (CPGLS) shall be responsible for monitoring and conducting of the LL.M. Degree Programme. Only those students who successfully complete their LL.M. degree component of the Integrated LL.M. Ph.D. in their first attempt securing not less than 55% marks each for the End Semester Assessment and Continuous Assessment Components for each of the courses with an aggregate minimum of 60% marks for the LL.M. Degree shall be eligible to be considered for Ph.D. Programme subject to their successful selection based on a presentation of their Ph.D. proposal and the interview to assess their suitability with other candidates of Ph. D. Programme of the concerned year.

Fellowship

The students admitted to the Integrated LL.M., Ph.D. Programme are eligible to avail financial aid only if they are selected for the Ph.D. Component of the Programme. On successful completion of LL.M. Degree, the candidates are eligible to receive a fellowship of Rs.20,000/- (Rupees Twenty thousand only) per month. The initial fellowship due for the first

two years of the LL.M. Degree Programme shall be disbursed only within three months from the date of joining for Ph.D. For the subsequent three years they are eligible for a monthly fellowship of Rs.20,000/- (Rupees Twenty Thousand only) and a contingent grant of Rs.30,000/- (Rupees Thirty Thousand only) per annum.

Commencement of Classes and Induction Programme

The classes shall commence on July 1, 2022. The candidates who are selected to the Integrated LL.M. Ph.D. programme have to undergo a mandatory induction in the first week of joining the Programme. General rules of conducting the courses as per the Act and exercise of power by statutory bodies of the University are applicable to this course. Integrated LL.M. Ph.D. Regulations shall govern the entire conduct of the Programme.

Syllabus for NUALS Integrated LL.M. Ph.D. Programme Entrance Examination

The NUALS Integrated LL.M. Ph.D. programme emphasises on the comprehension abilities of the students. Objective type questions will be comprehension based and will be asked from given passages. There will be only 120 objective-type questions carrying one mark each. There shall be a negative marking of 0.25 marks for each wrong answer.

Duration: 120 Minutes /2.00 Hours

Syllabus: Constitutional Law, Jurisprudence, Administrative Law, Law of Contract, Torts, Family Law, Criminal Law, Property Law, Company Law, Public International Law, Tax Law, Environmental Law, and Labour & Industrial Law.

The candidates will be provided extracts from primary legal materials such as important court decisions in various fields of law, statutes or regulations. Each passage will be followed by a series of questions that will require them to demonstrate the: a) Ability to read and comprehend the issues discussed in the passage, as well as any arguments and viewpoints discussed or set out in the passage; b) Awareness of the issues discussed in the passage, as well as of legal issues and facts related to and arising out of the passage and the judgment or statute from which it is extracted; c) Summarise the passage; and d) Ability to apply your knowledge of the fields of law discussed in the passage.

Guidance

Read and refresh your knowledge of important judgments, and try to discern various issues discussed in such judgments;

Refresh your knowledge of important constitutional and legislative provisions, particularly those that may have been discussed in recent judgments; it would also be useful to ensure you are aware of historical case law and amendments related to such provisions, so that you have a more complete awareness of such provisions and the issues related to them.
