Applications are invited from qualified candidates for admission by way of 'Inter-University Transfer' to the 3rd Semester of the 5 Year B.A. LL.B. (Hons.) Degree Course of NUALS during the academic year 2021-22 admission shall be subject to the provisions in the Regulations of NUALS and the approved norms governing Inter-University Transfer, as given below:

Norms governing Inter-University Transfer:

- a) Ordinarily students will be admitted only to the 3rd Semester of the B.A. LL.B. (Hons.) Course.
- b) Those students who were ranked in the CLAT Rank List in the previous year will be given preference in the matter of Inter-University Transfer.
- c) Those students who are admitted in the 3rd Semester by Inter-University Transfer shall have to remit all the prescribed fees for the first two semesters.
- d) The subjects prescribed by the Bar Council of India for the award of LL.B. Degree, in which the student has already undergone instruction and has been declared to have passed by the University/Institution concerned, will be considered for exemption. In respect of the remaining subjects prescribed by the BCI, if any, for which such students have neither been given instruction earlier nor had passed as per the respective regulations of those institutions, they will have to appear and pass the examinations in NUALS.
- e) The internal assessment marks for the previous Semesters will not be considered or taken into account for finalizing the results in respect of students who get admissions by Inter-University Transfer.
- f) The candidates are required to undergo internal assessment examination for all papers he/she has to appear/reappear at NUALS.
- g) The students who are admitted to NUALS by Inter-University Transfer shall be declared to have passed in the Second Class even if they secure 60% or more marks in the aggregate.
- h) The students who are admitted to NUALS by Inter University Transfer shall undergo the life skill course in the first and second semesters.
- i) The norms for working out internal assessment marks shall be as prescribed in the University Order No. NUALS/EC/34th 228/12 dated 22.08.2012

Application for Inter-University-Transfer shall be submitted in the prescribed format appended with this notification. An application fee of Rs.5,000/- (Rupees Five Thousand Only) shall be remitted along with the application by way of Demand Draft drawn in favor of 'The National University of Advanced Legal Studies' payable at Ernakulam/Kochi. The last date for receipt of filled in applications shall be 4.00 p.m. on13.10.2021
