In exercise of the powers conferred under Section 27 of the National University of Advanced Legal Studies (NUALS) Act, 2005, as amended by the National University of Advanced Legal Studies (Amendment) Act, 2008, the Chancellor of NUALS, the Hon'ble Chief Justice, High Court of Kerala, is pleased to constitute and appoint a Search Committee for recommendation of a suitable person for being considered for appointment of the Vice-Chancellor of NUALS under Sub-Section 3 of Section 8 of the Act.

The Search Committee constituted by the Chancellor of NUALS invites applications from eligible candidates for recommendation of a suitable person for being considered for appointment as the Vice-Chancellor of the National University of Advanced Legal Studies (NUALS), Kochi.

- The candidate shall be a distinguished academician with highest level of competence, integrity, morals and institutional commitment, with a minimum of 10 years of experience as Professor in the University system or 10 years of experience in a reputed research and/or academic administrative organisation in an equivalent post with proof of having demonstrated academic leadership.
- The term of office of the Vice-Chancellor shall be four years from the date on which he enters upon his office or until he attains the age of 65, whichever is earlier.
