A candidate who selected the <u>Freeze Option</u> in the **Third round** of counseling must pay the remaining University Fee (after adjusting the Counselling Registration Fee and Confirmation Fee) to NUALS concerned by **5 P.M. on June 27, 2025**).

Fee Payment at NUALS

All candidates who have selected the **Freeze option** in the **first and second** round of counselling must pay the balance University Fees (after adjusting for the Counselling Registration Fee and Confirmation Fees already paid) at NUALS by **5 P.M. on June14, 2025.** All candidates who have selected the **Freeze option** in the **Third round** of counselling must pay the balance University Fees (after adjusting for the Counselling Registration Fee and Confirmation Fees already paid) at NUALS by **5 P.M. on June 27, 2025** Any such candidate who fails to pay their balance University Fees by this date will be deemed to have chosen the Exit option and will forfeit their seat.
