NOTIFICATION

The National University of Advanced Legal Studies (NUALS), Kochi, invites applications from eligible and well experienced persons for the post of REGISTRAR of the University:

1. METHOD OF RECRUITMENT

By Direct Recruitment or on Deputation Basis from a Foreign Service.

2. QUALIFICATIONS & EXPERIENCE

- A) A Master's Degree in Law with at least 55% of Marks or an equivalent grade in a point scale wherever grading system is followed.
- B) At least 15 years' experience as Assistant Professor in the Academic Level 11 and above or with 8 years of service in the Academic Level 12 and above including as Associate Professor along with experience in educational administration.

OR

Comparable experience in research establishment and/ or other institutions of higher education.

OR

Fifteen years of Administrative experience of which 8 shall be as Deputy Registrar in a recognized University or an equivalent post.

3. SCALE OF PAY FOR THE POST

The scale of Pay will be at Academic Level 14 of the UGC Scale.

4. AGE: The Upper Age limit for applying to the post shall be 48 Years as on the date of Notification with a relaxation of 5 Years and 3 Years in the upper age limit for candidates belonging to the SC/ST and OBC category, respectively.
