The candidates may also remit an application fee of Rs.5,000/- (Rupees Five thousand only) by way of a Demand Draft drawn in favor of ‘the Registrar, the National University of Advanced Legal Studies’ payable at Kochi/ Ernakulam. The norms for admission against seats reserved for NRI Sponsored Candidates and Foreign Nationals are appended.

**Norms for admission to the B.A. LL.B. (Hons.) Degree Programme under the NRI  
Sponsored Category**

1. NRI Sponsored seats are applicable to such candidates who are being sponsored by an NRI/OCI/PIO for undergoing the course of study during the entire duration of the Course. The number of seats available for NRI Sponsored candidates is 6 (Six). If sufficient candidates are not available under the NRI Sponsored quota, such vacant seats shall be filled from the All India General Category candidates in the order of CLAT merit.
2. The candidates under this category should have passed an examination recognized by the Association of Indian Universities (AIU), New Delhi, as equivalent to the Higher Secondary Examination (10+2) under the Indian System, securing not less than 45 % of marks in the aggregate.
3. The candidate must have studied the English language as one of the compulsory subjects in 10+2 or equivalent Higher Secondary School Examination.
4. Candidates who are appearing/appeared in the qualifying examination are also eligible to apply. However, they should submit the result of their qualifying examination within the stipulated time notified by the University.
5. Candidates who seek admission under the NRI Sponsored Quota in NUALS are exempted from CLAT 2024.
6. The admission will be made strictly on the basis of inter se merit in their 10+2 examination or an equivalent examination.
7. The following documents should be enclosed with the filled in Application Form:
  - a. Copy of the statement of marks in the Qualifying Examination (i.e. an examination equivalent to 10+2) recognized by the Association of Indian Universities (AIU), New Delhi;

- b. Percentage Conversion Certificate from the School/Board, in case of Grades (if applicable);
- c. Copy of the Birth Certificate of the candidate;
- d. Copy of the Passport of the Sponsor;
- e. Copy of the valid Residence Permit of the Sponsor;
- f. Certificate from the Indian Embassy of the respective Country to prove the valid NRI status of the Sponsor;

**Norms for admission to the B.A. LL.B. (Hons.) Degree Programme under the Foreign Nationals Category**

1. The number of seats available for foreign nationals is 2 (Two). Preference shall be given to candidates from SAARC countries. If sufficient candidates are not available for Foreign National Category, such vacant seats shall be filled from the NRI Sponsored Quota. In case NRI Sponsored candidates are not available, the vacant seats shall be filled from the All India General Category candidates in the order of CLAT merit.
2. Candidates possessing the citizenship of a foreign country shall ONLY be considered for admission under this category.
3. The candidates under this category should have passed an examination recognized by the Association of Indian Universities (AIU), New Delhi, as equivalent to the Higher Secondary Examination (10+2) under the Indian System, securing not less than 45 % of marks in the aggregate.
4. The candidate must have studied the English language as one of the compulsory subjects in 10+2 or equivalent Higher Secondary School Examination.
5. Candidates who are appearing/ appeared in the qualifying examination are also eligible to apply but they should submit the result of their qualifying examination within the stipulated time notified by the University.
6. Candidates seeking admission in NUALS under Foreign Nationals quota are exempted from taking CLAT 2024.
7. The admission will be made strictly on the basis of inter se merit in their 10+2 examination or an equivalent examination.
