**Sub: CLAT 2025 – Admission to the One Year LL.M. Degree Programme – First, Second and Third/Final Allotment - Instructions to the candidates and schedule of fees – Reg.**

The candidates whose names appeared in the First, Second & Third Allotment Lists published by the Consortium of National Law Universities and allotted to the National University of Advanced Legal Studies, Kochi, through CLAT 2025 for admission to the One Year LL.M. Degree Programme are required to complete the following formalities:

A candidate who selected the **Freeze Option** in the **First and Second round** of counseling must pay the remaining University Fee (after adjusting the Counselling Registration Fee and Confirmation Fee) to NUALS concerned by **5 P.M. on June 30, 2025**).

A candidate who selected the **Freeze Option** in the **Third round** of counseling must pay the remaining University Fee (after adjusting the Counselling Registration Fee and Confirmation Fee) to NUALS concerned by **5 P.M. on July 10, 2025**).

Fee Payment at NUALS

All candidates who have selected the **Freeze option** in the **first and second** round of counselling must pay the balance University Fees (after adjusting for the Counselling Registration Fee and Confirmation Fees already paid) at NUALS by **5 P.M. on June 30, 2025**. All candidates who have selected the **Freeze option** in the **Third round** of counselling must pay the balance University Fees (after adjusting for the Counselling Registration Fee and Confirmation Fees already paid) at NUALS by **5 P.M. on July 10, 2025**. Any such candidate who fails to pay their balance University Fees by this date will be deemed to have chosen the Exit option and will forfeit their seat.

Schedule of Fees to be paid at NUALS



One Year LL.M. Degree Programme

The total fee for the One year LL.M. Degree Programme is Rs.1,82,870/- (Rupees One lakh Eighty Two Thousand Eight Hundred and Seventy only) and a refundable Caution Deposit of Rs.10,000/- (Rupees Ten thousand only). The Counselling Fee and Confirmation Fee remitted at the CLAT Office shall be adjusted in the fee. Hence, the total amount to be paid for confirmation of admission to the One Year LL.M. Degree Programme is,

(a) Rs. 1,42,870/- (Rupees One Lakh Forty Two Thousand Eight Hundred and Seventy only) including the Caution Deposit [(Rs.1,82,870 + Rs.10,000) – (Rs.30,000 + Rs.20,000)] for General Category candidates.

(b) Rs. 1,52,870/- (Rupees One Lakh Fifty Two Thousand Eight Hundred and Seventy only) including the Caution Deposit [(Rs.1,82,870 + Rs.10,000) – (Rs.20,000 + Rs.20,000)] for OBC/EWS/PWD (based on All India Category) candidates.

The candidates coming from institutions outside the State of Kerala are required to remit an additional amount of Rs.200/- (Rupees Two hundred only) towards Recognition Fee, i.e., such General Category candidates have to remit a total amount of Rs.1,43,070/- (Rupees One Lakh Forty Three Thousand and Seventy only) and such OBC/EWS/PWD (based on All India Category) candidates have to remit a total amount of Rs.1,53,070/- (Rupees One Lakh Fifty Three Thousand and Seventy only).
