Sub: CLAT 2020 – Admission to the 5 Year B. A. LL.B. (Hons.) Degree Course and One Year LL.M. Degree Course – Instructions to the candidates and schedule of fees – reg.

The candidates whose names appear in the Allotment Lists to be published by the Consortium of National Law Universities and allotted to the National University of Advanced Legal Studies, Kochi, through CLAT 2020 for admission to the 5 Year B.A. LL.B. (Hons.) Degree Course and One Year LL.M. Degree Course are required to complete the following formalities:

- 1. Candidates should login to their CLAT account and choose the option of their choice, i.e., 'Accept' / 'Upgrade' / 'Exit'.
- 2. Candidates who opt for 'Accept' / 'Upgrade' should remit the fee as given below to the University Account through online transfer.
- 3. Candidates should fill the online form and upload the documents through their login id in their CLAT account.
- 4. Based on the information provided and on verification of the documents submitted, the University will 'Accept' the candidate or may 'Not Accept'
- 5. All the above processes should be completed within the scheduled timeline provided in the Admission Counselling Guidelines on the website of the Consortium of NLUs. No extension of time will be given to the candidates beyond the dates indicated by the Consortium.
- 6. Candidates who fail to pay the fee to the University and submit the documents within the timeline as given in the Schedule will not be considered for admission and they will also not be considered for allotment in subsequent lists issued by the CLAT Consortium.
- 7. In case of candidates who opt for 'Upgrade', the total fee paid by them at NUALS will be transferred to the National Law University where they finally get admitted.
- 8. Candidates should submit the scanned copy of their documents and provisional admission will be offered based on the documents submitted. In case any discrepancy is found on a later date and / or on physical verification of original documents, the provisional admission offered will be cancelled.

Schedule of Fees to be paid at NUALS

B.A. LL.B. (Hons.) Degree Course

The total fee for the first year B.A. LL.B. (Hons.) Degree Course is Rs.1,96,870/- (Rupees One lakh Ninety six thousand Eight hundred and Seventy only) and a refundable Caution Deposit of Rs.10,000/- (Rupees Ten thousand only). The fee is to be paid in two instalments. In view of the Covid-19 epidemic, a special reduction of Rs.14,525/- (Rupees Fourteen thousand Five hundred and Twenty five only) is allowed from the first instalment to be paid at the time of admission. The Counselling Fee of Rs.50,000/- (Rupees Fifty thousand only) remitted at the CLAT Office shall also be adjusted in the first instalment of Rs.1,02,620/- (Rupees One lakh Two thousand Six hundred and Twenty only) [Academic Fee: Rs.94250 + Other Fee: Rs.8370 = Rs.1,02,620/-].

Hence, the total amount to be paid by the candidate for confirmation of admission to the B.A. LL.B. (Hons.) Degree Course is Rs.48,095/- (Rupees Forty eight thousand and Ninety five only) including the Caution Deposit (Rs.1,02,620 – Rs.14,525 – Rs.50,000 + Rs.10,000). The candidates coming from institutions outside the State of Kerala is required to remit an additional amount of Rs.200/- towards Recognition Fee, i.e., such candidates have to remit a total amount of Rs.48,295/- (Rupees Forty eight thousand Two hundred and Ninety five only).

One Year LL.M. Degree Course

The total fee for the One year LL.M. Degree Course is Rs.1,37,870/- (Rupees One lakh Thirty seven thousand Eight hundred and Seventy only) and a refundable Caution Deposit of Rs.10,000/- (Rupees Ten thousand only). The fee is to be paid in two instalments. In view of the Covid-19 epidemic, a special reduction of Rs.7,225/- (Rupees Seven thousand Two hundred and Twenty five only) is allowed from the first instalment to be paid at the time of admission. The Counselling Fee of Rs.50,000/- (Rupees Fifty thousand only) remitted at the CLAT Office shall also be adjusted in the first instalment of Rs.73,370/- (Rupees Seventy three thousand Three hundred and Seventy only) [Academic Fee: Rs.64,500 + Other Fee: Rs.8,870].

Hence, the total amount to be paid by the candidate for confirmation of admission to the One Year LL.M. Degree Course is Rs.26,145/- (Rupees Twenty six thousand One hundred and Forty five only) including the Caution Deposit (Rs.73,370 – Rs.7,225 – Rs.50,000 + Rs.10,000). The candidates coming from institutions outside the State of Kerala is required to remit an additional amount of Rs.200/- towards Recognition Fee, i.e., such candidates have to remit a total amount of Rs.26,345/- (Rupees Twenty Six thousand Three hundred and Forty five only).
