If admitted, the candidates have to remit the prescribed fees by way of online transfer to the University account.

The total fee for the first year B.A. LL.B. (Hons.) Degree Course is Rs.1,96,870/-(Rupees One lakh Ninety six thousand Eight hundred and Seventy only) and a refundable Caution Deposit of Rs.10,000/- (Rupees Ten thousand only). The fee is to be paid in two instalments. The first instalment of fees is Rs.1,02,620/- (Rupees One lakh Two thousand Six hundred and Twenty only) [Academic Fee: Rs.94250 + Other Fee: Rs.8370 = Rs.1,02,620/-].

Hence, the total amount to be paid by the candidate for confirmation of admission to the B.A. LL.B. (Hons.) Degree Course is Rs. 1,12,620/- (Rupees One Lakh Twelve thousand Six Hundred and Twenty only) including the Caution Deposit (Rs.1,02,620 + Rs.10,000). The candidates coming from institutions outside the State of Kerala is required to remit an additional amount of Rs.200/- towards Recognition Fee, i.e., such candidates have to remit a total amount of Rs.1,12,820/- (Rupees One Lakh Twelve thousand Eight Hundred and Twenty only).
